

Your accreditation reference number is 129379.

Please print this letter and bring it together with the proper identification to the Accreditation Centre in order to receive your accreditation badge. For international visitors, this will be your passport. For South African residents, this will be your South African identity document or passport, whichever you specified when you applied for accreditation.

If you are not a South African resident, you are required to carry a passport valid for no less than 30 days after the expiry of the intended visit. The passport must contain at least 1 (one) unused page for entry/departure endorsements (sometimes referred to as visa page).

This letter will serve as your visa (should you require one) for entry to South Africa. You are required to carry this confirmation letter at all times and present it on request to the respective airlines or border authorities when travelling to South Africa. No electronic version of this letter on laptops, cell phones or other electronic media will be accepted.

Please note that the Department of Home Affairs (DHA) will notify all airlines and airports authorities about the immigration and visa procedures for the 2010 FIFA WORLD CUP SOUTH AFRICA™ in order for such authorities to facilitate the transit of the travellers with ease. The DHA, however, recognizes that some foreign states may expect the transiting traveller to produce the necessary transit visa or related document in spite of such a traveller being in possession of the Accreditation documents.

The Organising Committee wishes to remind travellers who will be transiting between states to contact their local Immigration Authorities or the respective South African Missions abroad to ascertain what the legal transit requirements will be and if so advised, to apply for a transit visa.

  - Accommodation details – name of hotel/accommodation venue, physical address, and contact person and number. Ensure that you print and carry the letter of confirmation when you arrive in South Africa;
- A valid Passport, with at least 3 full blank pages (as required of Department of Home Affairs);
- A valid immunisation certificate for those countries that fall within the yellow fever belt (details available from Department of Home Affairs at <http://www.home-affairs.gov.za/site2010/index.html>).
